

(3) Waiting limited to 1 hour in 2, 8.30 a.m. to 6.30 p.m. on Mondays to Saturdays on:

- (a) High Street (A228), on the east side from a point 43 metres south of the southern boundary wall of No. 81 High Street (A228) for a distance of 5 metres southwards, and on the west side from the southern boundary of the property known as "Fosters" to the southern boundary of "Old Vicarage";
- (b) Police Station Road on the east side from a point 101 metres north of the centre of its junction with Swan Street for a distance of 28 metres northwards.
