TOWN AND COUNTRY AMENITIES ACT 1974

Notice is hereby given, that the Leominster District Council in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 have extended the area of the Bodenham Conservation Area:

Bodenham Conservation Area as previously designated showed the southern boundary running along the hedgerows of the fields on the south and south-western sides of the River Lugg to the bridge which is included. The boundary then runs behind the property at the east end of the village and follows the domestic boundaries to a track which runs along the northern edge of the village on the side of the hill. At the western end the boundary runs back to the main road along the last domestic curtilage, then follows the road westward to a stone gate pier on the south side of the road immediately opposite to the western entrance to Bodenham School and then strikes south across the gravel workings to the hedgerow between field parcel 4774 and 8671. The boundary included Ashgrove Wood and the adjoining copse, and returns to the hedgerow adjoining field parcel 8671 and 2545.

The Bodenham Conservation Area as extended will, after the track running along the northern edge of the village, follow the route of bridleway BM1 in a westerly direction until it reaches a track leading north to Ashen Grove Wood when the Conservation Area boundary will turn south and follow field boundaries in a southerly, then westerly, then southerly direction and again in a westerly direction along the edge of the Site of Special Scientific Interest and behind properties known as Pine Lodge and Southbourne, then along the northern side of the C1121 roadway until the eastern edge of woodland known as Hoarstone Rough where it will travel in a southerly direction to the southern side of the River Lugg where the boundary will follow the left bank of the river until it rejoins the boundary of the original Conservation Area.

Plans showing this area can be inspected during normal working hours at the Planning Office of Leominster District Council at Broad Street, Leominster.

The effect of the designation will be that no person may, without the written consent of the Council, demolish any building within the Conservation Area. Offences against these provisions may result in heavy fines.

The Council will also give special attention to the desirability of preserving or enhancing its character or appearance with respect to any buildings or other land in the area of the Conservation Area.

OPENCAST COAL ACT 1958

The Bannel Bridge Rights of Way Application 1990

If the District Council or County Council in whose area any part of the rights of way lie objects and do not withdraw their objection the Secretary of State must arrange a public inquiry: if any other person objects and does not withdraw his objection he may arrange a public inquiry if he thinks fit.
