TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping-up of Highways (County of Tyne and Wear) (No. 9) Order 1990" authorising the stopping-up of various small areas of the north-western footway of Market Street, the south-western footway of Carlol Street and the north-eastern and south-eastern sides of Erick Street, Newcastle-upon-Tyne. None of the areas extends more than 0.22 metres from the present boundaries of Bamburgh House and the stopping-up is necessary to enable development consisting of the replacement of an existing mosaic finish on elevations of Bamburgh House to be carried out in accordance with planning permission granted to Electricity Supply Nominees on behalf of Waring and Netts Partnership by Newcastle-upon-Tyne City Council under Part III of the said Act.
