### NEW TOWNS ACT 1981

*The New Town of Milton Keynes (Extinguishment of Public Rights of Way over Willen Road-Pineham (Adjacent to Cotton Valley Sewage Treatment Works)).*

That length of Willen Road from a point marked "A" on the map, approximately 140 metres south of the river Ouzel and running in a generally southerly direction for approximately 470 metres to a point marked "B" approximately 60 metres north of the City Road H5 Portway.
