#### HIGHWAYS ACT 1980

##### *The Leicester–Great Yarmouth Trunk Road (A47) (Narborough Bypass) Order 1990*

The Secretary of State for Transport hereby gives notice that he has made an Order under section 10 of the Highways Act 1980, the effect of which is to provide that a road 3.15 kilometres in length which he proposes to construct from a point 150 metres east of the existing A47 trunk road junction with B1153 then going in a generally south-easterly direction to rejoin the existing trunk road at a point 580 metres west of the Bench Mark at Stella's Farm at Narborough in the county of Norfolk shall become a trunk road as from the date when the Order comes into force.

Copies of the Order and the relevant plan have been deposited at the Department of Transport, 2 Marsham Street, London S.W.1 and at the offices of the Director (Transport), Eastern Construction Programme Division at the address shown below; of Norfolk County Council, Martineau Lane, Norwich; and at Narborough Sub-Post Office, where they are open to inspection free of charge at all reasonable times.

#### HIGHWAYS ACT 1980

##### *The Leicester–Great Yarmouth Trunk Road (A47) (Narborough Bypass) Supplementary Side Roads Order 1990*
