## HIGHWAYS ACT 1980, SECTION 119

*The Borough of Chelmsford (Bridleway No. 29 (Pleshey) and Footpath 111 (Great Waltham)) Public Path Diversion Order (No. 2) 1990.*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 31st July 1990, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Borough Council of Chelmsford as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way described in Part I of the Schedule hereto to the line described in Part II thereof.

A copy of the Order and the map contained in it are available in Room 32, Administration Department, Civic Centre, Duke Street, Chelmsford, where it may be inspected free of charge during normal office hours.

Any representations or objection with respect to the Order may be sent in writing to the undersigned within 28 days of the date of this notice, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Borough Council of Chelmsford may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for the Environment for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

## SCHEDULE

## Part I

*Description of site of existing bridleway and path*

*Bridleway 29 (Pleshey)*, from a point in Honeypot Lane indicated on the plan as point A due north for a distance of approximately 300 metres to a point indicated on the plan as point B.

*Footpath 111 (Great Waltham)*, from a point in Honeypot Lane indicated on the plan as point D east by north of a distance of approximately 80 metres, and thence in a north-easterly direction for a distance of approximately 300 metres to a point indicated on the plan as point E.

## B

*Description of site of new bridleway and path*

*Bridleway 29 (Pleshey)*, from point A in a generally easterly direction for a distance of approximately 350 metres to a point indicated on the plan as point C. The bridleway shall be a minimum of 3 metres in width throughout this section.

*Footpath 111 (Great Waltham)*, from point E due south for a distance of approximately 490 metres to a point indicated on the plan as point F. The footpath shall be a minimum of 2 metres in width throughout this section.

*The Cheshire County Council (A538 Prestbury Road Link, Wilmslow Classified Roads (Side Roads) Order 1990*

Notice is hereby given that Cheshire County Council hereby give notice that they have made and submitted to the Secretary of State for Transport for confirmation an Order under sections 14 and 125 of the Highways Act 1980, for authorising the Council:

- (a) to carry out the improvement of highways;
- (b) to stop up highway;
- (c) to stop up private means of access to premises;
- (d) to provide new means of access to premises.

All on or in the vicinity of the route of the classified road which the Council are proposing to construct from the proposed roundabout on the A34 Wilmslow Local By-Pass at Thorngrove School in an easterly direction for approximately 0.8 kilometres to the A538 Prestbury Road at its junction with Hough Lane, in the Borough of Macclesfield, in the County of Cheshire.
