The A45 Trunk Road (Weedon Road, Northamptonshire) (Prohibition of U-turns) Order 19

Prohibition of U-turns through gaps in the Central Reservation of the Trunk Road

### Part I

# (Westbound Traffic)

The gap approximately 1,100 metres east of the junction of that road with the northern side of the roundabout at Junction 16 on the M1 Motorway, and 300 metres east of the Red Lion Public House.

### Part II

# (Eastbound and Westbound Traffic)

The gap at the junction of that trunk road with Northampton Road, at Harpole.

The gap approximately 160 metres east of the junction of that road with the B4525, Sandy Lane, adjacent to South View.

2. The gap approximately 600 metres west of the junction of that road with Northampton Road, Harpole.

3. The gap approximately 620 metres east of the junction of that road with the B4525, Sandy Lane.

4. The gap approximately 980 metres east of the junction of that road with the B4525, Sandy Lane, opposite the entrance to Upton Lodge Cottages. (4 SI)

### **HIGHWAYS ACT 1980**

The Devon County Council (A386 Tavistock Road, Dualling, Plymouth, Stage 1, Woolwell to Roborough, Classified Road) (Side Roads) Order 1990.

The Secretary of State for Transport hereby gives notice that he has confirmed the above Order which was made by Devon County Council under section 14 of the Highways Act 1980, and which, as confirmed, provides for authorising the Council

(a) to carry out the improvement of highways,

(b) to stop up a highway,

(c) to construct a new highway,

all on or in the vicinity of the route of the classified road which the Council are proposing to construct at Plymouth.
