NOTICE TO BONDHOLDERS OF NUMBERS OF THE BONDS DRAWN FOR PAYMENT ON THE 1st NOVEMBER 1990

The Lords Commissioners of Her Majesty's Treasury hereby give notice that in accordance with the provisions of the Northern Ireland Land Act 1925 (15 and 16 Geo. V., c.34) and of the Northern Ireland Land (Finance) Rules 1926, made in thereunder, the within-mentioned Bonds amounting to £93,315, say ninety three thousand three hundred and fifteen pounds, were this day drawn for payment.

The Bonds will be paid off at par or after the 1st November 1990, at the Bank of England, London, unless registered in the Books of the Bank of Ireland, Belfast, in which case the Bonds will be redeemed at the Bank of Ireland, Belfast. Interest on the Bonds will cease from the 1st November 1990.

NOTE: Registered Bonds, accompanied by a request signed by all the Registered Holders for transmission of the Warrant for the Redemption money, must be presented at the Transfer Office (Guaranteed Bonds Section), Bank of England, New Change, London EC4M 9AA, unless registered in the Books of the Bank of Ireland, Belfast, in which case the Bonds must be presented at the Registration Department, Bank of Ireland, Moyne Buildings, First Floor, 20 Callender Street, Belfast BT1 5BN.

Bearer Bonds issued on or after the 27th July 1964 may be presented for payment at the Securities Office, Bank of England, Threadneedle Street, London EC2R 8AH or at any Branch or Agency of the Bank of England, accompanied by appropriate listing forms obtainable from the Bank of England, and should be left three clear days for examination (five days at a Branch or Agency).
