ROYAL WARRANT OF PRECEDENCE

The College of Arms

Her Majesty The QUEEN by Royal Warrant bearing date the twenty-seventh day of March 1990 has been graciously pleased to ordain and declare that Jean Mary wife of Michael James Babington-Smith and the sister of John Herbert Meade Earl of Clanwilliam should henceforth have hold and enjoy the same title rank place pre-eminence and precedence as the daughter of an Earl which would have been due to her had her father Herbert Meade-Fetherstonhaugh survived his kinsman John Charles Edmund Carson Earl of Clanwilliam and thereby succeeded to the title and dignity of Earl of Clanwilliam.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms. (18 SI)

The QUEEN has been graciously pleased to give and grant unto Michael Anthony Tudor Trevor-Barnston (formerly Michael Anthony Tudor Trevor) of Crewe Hill, Farndon in the County of Cheshire, Gentleman, Her Majesty's Royal Licence and Authority that he and his issue may bear the Arms of Barnston (that is to say the Arms and Crest of Barnston only); the said Arms being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms, otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of a length of Seventh Avenue, Blyth, to enable residential development consisting of the erection of 33 flats,

16 houses and one administration unit to be carried out in accordance with planning permission granted to North British Housing Association, Per: Greenall Bryce Associates by Blyth Valley Borough Council under Part III of the Town and Country Planning Act 1971. The proposed Order will require the provision of a footpath maintainable at the public expense, for which the Highway Authority is to be Northumberland County Council and the improvement of Seventh Avenue by the provision of a turning head.
