

## TOWN AND COUNTRY PLANNING ACTS

### THAMESDOWN BOROUGH COUNCIL

#### PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

##### *Designation of Conservation Areas*

Notice is hereby given that Thamesdown Borough Council has, with effect from the dates indicated, designated the following areas as conservation areas.

Plans showing the areas in detail can be inspected during office hours at the Department of Town Planning, Civic Offices, Euclid Street, Swindon SN1 2JH.

With effect from 30th April 1990—

- (a) An area in and around the village of Badbury, covering land on either side of a stretch of the road linking the Marlborough Road with Liddington, including the Baker's Arms public house; The Manor, and the buildings of Badbury House Farm and West Farm, together with other properties, to be known as Badbury Conservation Area.
- (b) An area in and around the village of Sevenhampton, covering land on either side of the main road through Sevenhampton; Roves Lane, and Bellingham Lane, including The Rookery; Crooked Path Copse; part of Dogkennel Copse; the buildings of Hill Farm; Sevenhampton Place and its grounds; St. James' Church; Sevenhampton House; The Reema Houses; The New Houses; The Lodge; Sevenhampton Farm; Bellingham Farm, together with other properties, to be known as Sevenhampton Conservation Area.
- (c) An area in and around Wroughton, including land on either side of Green's Lane; Bakers Road; The Pitchens; part of Priors Hill; part of the Marlborough Road, and Overtown Hill, together with other properties, to be known as Wroughton Conservation Area.
- (d) An area in and around the settlement of Hodson, lying off the B4005 road, to be known as Hodson Conservation Area.
- (e) An area in and around the settlement of Upper Inglesham, astride the A362 Highworth to Lechlade road, including Lynt Farmhouse; Manor Farm; Middle Hill Farm; The Old School House, together with other properties, to be known as Upper Inglesham Conservation Area.
- (f) An area in and around the village of Liddington, covering land either side of the A419, Purley Road; The Street; Church Road; The Green; Spinney Close and Manor View; Bell Lane; Lidenbrook, and part of Ham Road, including All Saints' Church, Parsonage House and the Rectory; Manor Farm; Liddington Manor, together with other properties, to be known as Liddington Conservation Area.

With effect from 25th June 1990—

- (a) An area of the town of Swindon, including stretches of North Street; South Street; King William Street; Stanley Street; Union Street, and Prospect Place, together with other properties, to be known as Swindon (Prospect Place) Conservation Area.
- (b) An area of the town of Swindon, covering short stretches of Cheney Manor Road, Vicarage Road, Akers Way and Beech Avenue, including areas surrounding St. Mary's Church and The Manor House, together with other properties, to be known as Swindon (Rodbourne Cheney) Conservation Area.
- (c) An area in and around the village of Chiseldon, covering Turnball; Slipper Lane; part of Hodson Road; New Road; part of Butts Road; Church Street; Stroud's Hill; May's Lane; High Street; The Canney; Saxon Mill, and part of Station Road, and including Holy Cross Church; Chiseldon House; the Manor House; the Methodist Church; the Elm Tree Inn, and the Library, together with other properties, to be known as Chiseldon Conservation Area.
- (d) An area in and around the settlement of Hampton, covering land adjacent to the Cricklade Road coming out of Highworth, and including Hampton Lodge and Hampton Farm, as well as Chesford Elms and The Old Farmhouse, together with other properties, to be known as Hampton Conservation Area.

With effect from 16th July 1990—

- (a) An area (in two parts) in and around the village of Broad Blunsdon, including Hunts Hill, Chapel Hill, the Heart in Hand Inn, portions of High Street and Burytown Lane, as well as the Village Hall (former School), Manor Farm House, St. Leonard's Church and the Rectory, together with other properties, to be known as Broad Blunsdon Conservation Area.

- (b) An area covering the site of Blunsdon Abbey, the Abbey gardens and grounds, and land around these, including Abbey Farm and its cottages; the Grange; St. Andrew's Church; Stepside and Abbey Lodge together with open space, pond and woodland, to be known as Blunsdon St. Andrew Conservation Area.
- (c) An area of the town of Swindon, covering a short length of Devises Road together with portions of Lethbridge Road, and Newport Street, and including the Church Hall; Swindon Evangelical Church; Swindon Spiritualist Church, and Clifton House, together with other properties, to be known as Swindon (Devises Road) Conservation Area.
- (d) An area in and around the settlement of Hinton Parva, including Church Row, Tuckers Lane and land adjoining the Wanborough to Bishopstone road, as well as Church Farm, Little Hinton Farm, Hinton Manor, Batts Farmhouse, Somerset Farmhouse, Orchard House, Povey's Cottage, Cannons Cottage, St. Swithin's Church and the separate cemetery, together with other properties, to be known as Hinton Parva Conservation Area.

The effect of designation as a conservation area will include the following:

- (1) Special attention will be paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, and where an application for planning permission is made for a development which would affect the character or appearance of the Conservation Area, such application will be advertised and representation made within a set period will be taken into account in determining the application.
- (2) Anyone wishing to demolish a building within the Conservation Area must first obtain Conservation Area Consent from the local Planning Authority (Certain buildings are excluded).
- (3) Except in certain cases, anyone proposing to do work on trees in the Conservation Area must give the local Planning Authority six weeks' notice of their intention before the work is carried out.

Notice is hereby given that Thamesdown Borough Council has, with effect from the dates indicated, designated the following areas as conservation areas.

These are redesignations altering the boundaries of existing conservation areas.

Plans showing the areas in detail can be inspected during office hours at the Department of Town Planning, Civic Offices, Euclid Street, Swindon SN1 2JH.

With effect from 30th April 1990—

- (a) an area in and around the village of Bishopstone, covering land on either side of the B4507 road between Wanborough and Ashbury; the High Street; Hocker Bench; West End Lane; Oxon Place, and Church Walk, including St. Mary's Church and The Old Vicarage; Cue's Farm; Prebendal Farm; Manor Farm; Forty Farm; Eastbrook Farm; the True Hart and Royal Oak public houses, together with other properties to be known as Bishopstone Conservation Area.
- (b) an area in and around the village of Castle Easton, covering land on either side of The Street; Long Row; Mill Lane; and parts of Church View and School Lane, including the Red Lion public house; St. Mary's Church and grounds; Manor Farm; Castle Eaton Farm, and Glebe House, together with other properties, to be known as Castle Eaton Conservation Area.
- (c) an area in and around the village of Wanborough, covering land on either side of the High Street; Callas Hill; Rotten Row, and Chapel Lane, including Hazeldene; York Cottage; Woodlands; Court Close; Slate Farm, and the Methodist Church, together with other properties, to be known as Lower Wanborough Conservation Area.
- (d) an area in and around the village of Wanborough, covering land on either side of the B4507, including Church Road, and part of Pack Hill, as well as Mayfield, The Lynchfield and parts of Southdown, Kite Hill and Warnage Green, including The
