Vienna, June 2. N.S. OME Days ago their Imperial Majesties went from the Castle of Laxembourg to Medling, where they laid the first Stone in the Foundation of a Pillar, which the Inhabitants of that Place are creeking, in memory of their Deliverance from the contagious Distemper. Courier is lately arrived here from France, with a Letter from the most Christian King to the Emperor, notifying the Death of the Duke of Berry-his Grandfon. The Empress-Dowager Emilia is removed with her whole Court to Schonbrun. Prince Philip of Heffe Darmstad has been constituted Velt-Marshal General, and Governor of the Dutchy of Mantua. The Troops that have been encamped for fome time near Erla, are upon their March towards Transilvania, where they are to be employed in the new Fortifications of Weiffenbourg. The Emperor is refolved not to disband any of his Forces, and thole in the Kingdom of Naples are order'd to be recruited. Count d'Efter-The Emperor is refolved not to disband hafi is lately gone from hence to Presbourg, and Prince Frederick of Wirtemburg is arrived here from Stutgard. It is faid, Prince Eugene is to vifit the Fortreffes in Hungary and Tranfilvania, before he fets out for the Congress of Baden. The Protestants of those Countries have made repeated Complaints to his Imperial Majefty, that the Po-pish Priests have taken away the Churches which the Turks had given them leave to build, and that Cardinal Saxe-Zeitz had ordered their Books of Prayer to be burnt. Directions are fent to Monfieur Fleischman, the Emperor's Refident at Confantinople, to acquaint the Ottoman Port, that three Camps are to be formed this Summer in Hungary, without any other defign than to ease the Inhabitants of the Country, who must other-twife be obliged to Quarter the Troops in their Houfes.

Hanover, June 12. N. S. The Electrefs Dowager found her felf indifposed on the Seventh at Night, but the next Morning she was much better, and writ a Letter with her own Hand to the Dutchefs-Dowager of Orleans her Niece. In the Evening the went out to walk in the Gardens of Herenhausen, where she was feized with a Fit of an Apoplexy, and died in the Arms of the Electoral Princefs and the Countels of Pickenbourg, who were walking with her, before any other Perfon could come up to her Affiftance. We are informed, that Preparations are making at Peterwaradin, in Hungary, for the reception of his Swedish Majesty, who is expected there very soon in his way to Vienna.

Hamburgh, June 15. N. S. Baron Sparr, who came hither a few Days ago to confult with General Welling, -upon the Affairs of Sweden and

Holftein, hath been feveral times in Conference with that Minifter, and is fince returned to Berlin in order to make fome further Propolals to his Pruffian Majefty. The Diet of Augsbourg hath publifhed a Mandate, exhorting the King of Denmark to reftore the Dutchy of Holftein to the Prince whom it appertains to, threatning, in cafe he refufes, to proceed againft him according to the Conftitution of the Empire. This Mandate hath been fent to the Empirer, who hath approved and confirmed it. His Danifh Majefty left Copenhagen on the 8th, and is expected very foon at Gottorp. The Governor of Wifmar being apprehenfive of an Attack, has order'd the Fortifications of that Place to be repaired with all poffibre diligence. The Garrifon confifts of Six thoufand Foot, and One thouland Dragoons, and the Fortrefs is for well provided with Ammunition, and Stores of all kinds, that it is thought they will be able to maintain a Siege for fix Months. Letters from Stockholm bring an account, that Vice Admiral Wattrang had been lately reinforced by fome Swediff Ships, and his Squadron, confifting of Nineteen Men of War, lay near Hungo, where the Sea is but three Leagues broad, by which means it was impoffible for the Muftovite Fleet to pafs by him without hazarding a Battle. We have receiv'd Advice from Poland, that the Grand Signior, in purfuance of the Treaty of Peace lately concluded with King Auguftus, and the Republick, had fent to King Staniflaus to retire out of the Dominions of the Ottoman Port.

Hague, June 19. N.S. On the 14th, the Marquis de Monteleone, together with feveral of the Plenipotentiaries of the States General, went from hence to Utrecht, in order to finish the Treaty of Peace between his Catholick Majesty and this Republick. To Morrow the Earl of Strassorie intends to set out for the same Place, his Excellency having received a Letter from the Spanish Ministers to desire his Presence there. The States General have lately come to a Resolution to open a Commerce again with the Town of Hamburgh, under certain Regulations and Restrictions. The States of Holland and West Frieseland are to asserted to Morrow.

St. James's, June 11. Yesterday the Queen removed from hence to Kensington, where she arrived in perfect Health.
