DERBYSHIRE COUNTY COUNCIL

Derbyshire County Council, (Borrowash) (Traffic Regulation) Order 1990

Notice is hereby given, that on 22nd November 1990 the Derbyshire County Council made an Order under section 1(1) and (2), 2(1) to (3) 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

When this Order comes into effect on 26th November 1990, you will not be allowed to:

1. Leave your vehicle in the following lengths of road at Borrowash.

No waiting at any time

Derby Road, both sides—from a point 73 metres west of its junction with Victoria Avenue to its junction with Station Road.

Nottingham Road, south side—from its junction with Station Road to a point 103 metres east of its junction with Gordon Road.

north side—from its junction with Station Road to a point 22 metres east of its junction with Gordon Road.

north side—from a point 39 metres east of its junction with Gordon Road to a point 103 metres east of that junction.

Victoria Avenue, west side—from its junction with Derby Road for 88 metres.

east side—from its junction with Derby Road to a point 20 metres north of its junction with Elm Street.

Elm Street, north side—from its junction with Victoria Avenue for 18 metres; and from a point 20 metres west of its junction with Nursery Close to a point 20 metres east of that junction.

south side—from its junction with Victoria Avenue to a point 20 metres east of its junction with Nursery Close.

Gordon Road, west side—from its junction with Nottingham Road to its junction with Central Avenue.

east side—from its junction with Nottingham Road for 30 metres; and from its junction with Central Avenue for 10 metres.

Central Avenue, north side—from a point 15 metres west of its junction with Gordon Road to a point 15 metres east of that junction.

Station Road, west side—from its junction with Derby Road for 59 metres.

east side—from its junction with Nottingham Road for 33 metres.

2. Leave your vehicle in the following lengths of roads at Borrowash during the times specified below:

Monday to Saturday 8 a.m. to 6 p.m. Waiting Limited to 20 Minutes Return Prohibited Within 1 Hour.

Nottingham Road, north side—from a point 22 metres east of its junction with Gordon Road to a point 39 metres east of that junction.

3. Drive along the following lengths of road at Borrowash other than in the direction specified:

One-Way Street

Gordon Road, from its junction with Nottingham Road to its junction with Central Avenue, traffic able to travel in a southerly direction only.

Note: It will be necessary to revoke the County of Derby (Borrowash) (Traffic Regulation) Order 1951; the Derbyshire County Council (Station Road, Borrowash) (Prohibition of Waiting) Order 1964; the Derbyshire County Council (Victoria Avenue, Borrowash) (Prohibition of Waiting) Order 1966; and the Derbyshire County Council (Gordon Road/Nottingham Road, Borrowash) (Prohibition of Waiting) Order 1980.

If you wish to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984 or on the grounds that any requirement of that Act or of any Instrument made
