#### MID GLAMORGAN COUNTY COUNCIL

*The Mid Glamorgan County Council (Maes-y-Felin, Caerphilly) (Prohibition of Waiting) Order 1991*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit the waiting of vehicles at any time on both sides of Maes-y-Felin, Caerphilly, from its junction with Mill Road, Route B4263, north-eastwards for a distance of 26 metres (28 yards).

Exemptions will be provided in the Order to enable Medical Practitioners and Veterinary Surgeons to visit while "on call" and for the purposes of boarding, alighting, loading, unloading, building and road works, the maintenance, improvement, reconstruction, inspection or survey of the length of road, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled person's vehicles displaying the relevant disabled person's badge will be allowed to wait up to 2 hours with return prohibited within 1 hour.

*The County of Humberside (Scunthorpe Borough and Glanford Borough) (Consolidation of Weight Restrictions and Revocation) Order 1990.*

Notice is hereby given that on 6th December 1990, the Humberside County Council made this Order which will be operative from 10th December 1990, and the effect of which will be to:

- (a) Prohibit any heavy commercial vehicles proceeding on parts of the following roads:

Banbury Road, Burringham Road (A159 and B1450), Doncaster Road (A18) Chancel Road (B1501), Grange Lane North, Grange Lane South (B1501), Greenhoe Road, Hebden Road, Hoylake Road, Kingsway (A18), Lunenburg Way, Messingham Road, Moorwell Road, Midland Road, Newdown Road, North Farm Road, Nostell Road, Queensway (A18), South Park Road, Sunningdale Road and West Common Lane.

- (b) Permit through routes for heavy commercial vehicles in the following roads:

Banbury Road, Burringham Road (A159 and B1450), Doncaster Road (A18), Grange Lane North (B1501), Grange Lane South (B1501), Hebden Road, Kingsway (A18), Messingham Road, Moorwell Road (C223), Midland Road, Nostill Road, Queensway (A18) and West Common Lane.

- (c) Permit through routes for heavy commercial vehicles in parts of the following roads:

Ashby Road (A159), East Common Lane, Ferry Road West (B1216), Lunenburg Way and Scotter Road.

- (d) To revoke the following Orders:

1. The County of Humberside (Parishes of Bottesford and Holme) (Through Routes for Heavy Commercial Vehicles and Weight Restriction) Order 1979.
2. The County of Humberside (Scunthorpe Borough) (Permitted Routes for Heavy Vehicles) Order 1980.
3. The Borough of Scunthorpe (Permitted Routes for Heavy Commercial Vehicles) (Amendment) Order 1984.
4. The County of Humberside (Scunthorpe Borough and Glanford Borough) (Scunthorpe and Gunness Area Zone) (Weight Restriction) Order 1984.
5. The County of Humberside (Flixborough and Gunness) Weight Restriction and One-Way Route for Heavy Commercial Vehicles) Order 1985.

Exemptions will permit the conveyance of goods, the use of agricultural equipment, the maintenance of roads, the supply and maintenance of gas, water and electricity, building operations, access to premises where the vehicle is being garaged, serviced or repaired.
