Waiting restricted to 30 minutes 10 a.m. to 6 p.m.

(1) Purewell, north side, from a point 120 metres east of its junction with Stony Lane for a distance of 35 metres in an easterly

(The effect of this will increase the length of the existing restricted waiting area by about 10 metres.)

The A390 road at Loastwithiel, from its junction with the B3269 road at No Man's Land to its junction with Castle Hill.

CORNWALL COUNTY COUNCIL

The County of Cornwall (Truro) (Newham Road) (Restrictions on Driving) Order 1991

Notice is hereby given that the Council propose to make the above Order to regulate traffic on the following lengths of road at Truro:

- (i) Morlaix avenue (A29);
- (ii) the Unclassified slip road leading in a generally westerly direction frm Newham Road into Morlaix Avenue (referred to as "the Slip Road");
- (iii) the newly-constructed length of Newham Road (Unclassified) leading in a generally southerly direction from the Fairmantle Street roundabout to its junction with the Slip Road (referred to as "Newham Road");
- (iv) the Unclassified access road to Newham House-between its junctions with Newham Road and the Slip Road (referred to as 'the Access Road").

The effect will be:

- (c) to impose a mandatory left turn frmo the Slip Road into Morlaix Avenue;
- (d) to prohibit any vehicle from turning left from Morlaix Avenue into the Slip Raod; and
- (e) to prohibit the use by motor vehicles of the Access Road (other than vehicles entering or leaving the driveway of Newham House).
