(a) *City of Coventry (Holbrooks Lane) (Urban Clearway) Amendment Order 1990*

This Order seeks to amend the City of Coventry (Holbrook Lane) (Urban Clearway) Order 1990 by introducing certain exemptions.

(b) *City of Coventry (Bedford Street/Gordon Street) (Prohibition and Restriction of Waiting) Order 1990*

This Order seeks to prohibit waiting at certain times on various lengths of Bedford Street and Gordon Street and to consolidate an existing Order.

DERBYSHIRE COUNTY COUNCIL

Derbyshire County Council (Ilkeston Road, Sandiacre) (Restricted Road) Order 1990
