GATESHEAD METROPOLITAN BOROUGH COUNCIL

The Borough Council of Gateshead (Sundew Road, Beacon Lough Estate) (Prohibition of Waiting) Order 1990

Notice is hereby given that on 11th December 1990, the Borough Council of Gateshead made an Order under sections 1(1) and (2), 2(1) to (3) of the Road Traffic Regulation Act 1984.

MID GLAMORGAN COUNTY COUNCIL

The Mid Glamorgan County Council (Pearce's Court, Cefn Coed-y-Cymmer) (Prohibition of Waiting) Order 1990
