Parking Places Amendments—Diplomats' Parking Places

Notice is hereby given that the Westminster City Council propose to make the City of Westminster (Free Parking Places) (Diplomatic Missions) (No.) Order 1990, the City of Westminster (Parking Place) (No.) Order 1990 under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

The general effect of the Order would be to:

- (a) provide diplomats' parking places in Exhibition Road, Grosvenor Gardens, Prince Consort Road and York Street;
- (b) extend certain diplomats' parking places in Belgrave Place, Davies Street, Grosvenor Square and Wilton Crescent;
- (c) shorten a certain 2-hour metered parking place in Crawford Street and replace it with a diplomats' parking place;
- (d) shorten a certain residents' parking place in Wilton Crescent to accommodate the extended diplomats' parking place;
- (e) provide that the initial charge in the 2-hour metered parking place would be at the rate of £1 for 30 minutes (maximum initial period 2 hours), the excess charge (payable to Westminster City Council) would be £30, the excess period would be 30 minutes, any unexpired time shown on a parking meter may be used free of charge, the period during which a vehicle may not return to a parking place would be 1 hour and the vehicles which may be left in the parking place shall be passenger vehicles (12 seats or less) certain goods carrying vehicles, motor cycles and invalid carriages;
- (f) provide that the vehicles which may be left in the residents' parking place shall be those displaying a valid parking card bearing the letter "A", issued by the City Council in respect of that vehicle. The charge for the use of the residents' parking place would be 50p per day, unless a valid season ticket is displayed. Season tickets cost £15 for 3 months or £55 for 12 months;
- (g) provide that the metered and residents' parking places would operate between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays and between 8.30 a.m. and 1.30 p.m. on Saturdays;
- (h) provide that certain vehicles may wait in the metered and residents' parking places free of charge in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit);
- (i) provide that only those vehicles used by the Head and members of staff of diplomatic missions may be left in the diplomats' parking places at any time, without charge or time limit.

WILTSHIRE COUNTY COUNCIL

Wiltshire County Council (Lyneham) (Calne Road & Pound Close) (Prohibition of Waiting) Order 1990

No waiting at any time
