At Walcot Street Multi-storey Car Park, where payment is required before leaving, an excess charge of £15 would be payable.

(Notes:

(1) Invalid carriages, disabled persons' vehicles which display a disabled person's badge, and pedal cycles are permitted to use any of the above parking places free of charge, except the Sawclose parking place where motor cycles with two wheels and pedal cycles are not permitted.

(2) Only those charges which are altered are set out above. All other charges payable under the existing Order remain unchanged.)
