Importation of Animal Products and Poultry Products Order 1980 (As Amended)

Notice is hereby given that as provided by Article 4 of the Importation of Animal Products and Poultry Products Order 1980 (as amended) the Ministry of Agriculture, Fisheries and Food and the Welsh Office, Agriculture Department have, with effect from 20th September 1990, issued the following licences with conditions as detailed below:

A. NEW GENERAL LICENCES

Licence (a) valid through: Dover (Eastern Docks), Felixstowe, Folkestone, Gatwick Airport (cartoned meat only), Great Yarmouth, Grimsby (cartoned meat only), Harwich (Parkestone Quay), Heathrow Airport (cartoned meat only), Heysham (cartoned meat only), Immingham (cartoned meat only), Isle of Grain (cartoned meat only), Kingston upon Hull (cartoned meat only), Liverpool Free Port (Gladstone Dock), Liverpool Free Port (Seaforth Dock) (cartoned meat only), Newhaven, Poole, Portsmouth, Ramsgate, Sheerness, Southampton (cartoned meat only), Tilbury, Tyne (North Shields) (cartoned meat only), Weymouth (cartoned meat only).

Licence (b) valid through: Fishguard, Holyhead and Milford Haven.

(c) bore, in accordance with the legal provisions a mark indicating their region of origin;

(d) have been subjected to an intra-dermal mallein test carried out by an official veterinarian according to the regulations of the veterinary service of Turkey with negative results within 15 days before being slaughtered; and

(e) following the mallein test, have not been in contact with animals which do not comply with the conditions required for export of their meat to the Community before being slaughtered.

B. Any meat imported under this licence shall be made available if so required for inspection by an Officer of the Ministry at any place nominated by him for such inspection. The importer or his agent shall afford all assistance necessary to such an Officer to enable him to carry out the inspection in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection.

Conditions attaching to licence A

A. Each consignment must be accompanied by a certificate in accordance with the terms of the Commission Decision No. 90/445/EEC made under Council Directive 72/462/EEC, as amended, signed by an official veterinarian of the Government of Turkey stating:

1. (a) Details of consignment (species of animal, nature of cuts, nature of packaging, number of cuts or packages, net weight).
- (b) Address(es) and veterinary approval numbers of approved slaughterhouse(s) and cutting plant(s).
- (c) Destination of meat (place of loading, country and place of destination, means of transport, names and addresses of consignor and consignee).
