The Nottingham (19) Smoke Control Order 1991

The Nottingham (20) Smoke Control Order 1991

Notice is hereby given that Nottingham City Council propose to make Orders entitled the Nottingham (19) Smoke Control Order 1991 and the Nottingham (20) Smoke Control Order 1991 declaring the areas described in the Schedule hereto to be smoke control areas.

Subject to the exemptions provided by virtue of section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control areas, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

It is proposed that the Orders will come into operation on 1st October 1991.

Copies of the draft Orders and the maps referred to therein may be inspected, free of charge, at the City Secretary's Department, the Guildhall, Nottingham, from 8.30 a.m. to 4.30 p.m. Monday to Friday for a period of 6 weeks from 17th December 1990.

Within that period any person who will be affected by the Orders may, by notice in writing to me, object to the making of those Orders.
