Notice is hereby given that the Council of the London Borough of Croydon propose to make an Order under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Road Traffic Regulation (Parking) Act 1986 to come into operation on a date to be agreed which may be cited as the Croydon (Parking Places) (No. ) Order 199 .

- 2. The general effect of the Order will be to:
- (a) revoke the designation by the Croydon (Parking Places) (No. 1) Order 1977, as amended, the Croydon (Free Parking Places) No. 1 Order 1977, the Croydon (Parking Places) (No. 1) Order 1979, the Croydon (Parking Places) (No. 2) Order 1981 and the Croydon (Parking Places) (No. 1) Order 1990 of all metered parking places, free parking places and 'pay and display' parking places located in the area bounded by Old Town, Roman Way (part), Cairo New Road, Ruskin Road, Tamworth Road, Station Road, Wellesley Road, Bedford Park, Bedford Place, BR railway line, Cherry Orchard Road (part), Addiscombe Road (part), Addiscombe Grove, Fairfield Road (part), Chatsworth Road, Coombe Road (part), High Street (part), West Street and Lower Coombe Street.

(b) designate parking places on the highways listed in Schedules 1,2, 3 and 4 at which charges may be made by the Council for the

leaving of vehicles authorised by the Order;

(c) specify that passenger vehicles (with 12 seats or less), goods carrying vehicles, motor-cycles and invalid carriages might be left in the parking places;

(d) provide that the parking places listed in:

(i) Schedule 1 will be in operation between the hours of 10 a.m. and 3.30 p.m.

(ii) Schedules 2, 3 and 4 will be in operation between the hours of 9 a.m. and 5 p.m.

on Mondays to Saturdays (inclusive) except Christmas Day, Good Friday and Bank Holidays.

(e) provide that the parking places listed in:

(i) Schedules 1 and 2 will be controlled by means of 'pay and display' parking only with payment to a ticket parking meter.

(ii) Schedules 3 and 4 will be controlled by means of 'pay and

(ii) Schedules 3 and 4 will be controlled by means of 'pay and display' parking with payment to a ticket parking meter or by the display of a valid Residents' Parking Permit.

(f) provide that at the parking places situated on the highways specified:

(i) in Schedule 1 the charge for leaving a vehicle varies from 10p for 6 minutes up to £2 (maximum) for 2 hours (maximum);

(ii) in Schedule 2 the charge for leaving a vehicle varies from 10p for 10 minutes up to £1.20 (maximum) for 2 hours (maximum);

(iii) in Schedule 3 the charge for leaving a vehicle varies from 10p for 10 minutes up to £1.20 (maximum) for 2 hours (maximum), or a vehicle displaying a valid Residents' Parking Permit, available from the London Borough of Croydon at a cost of £10 per annum, may park for a period of 8 hours (maximum);

(iv) in Schedule 4 the charge for leaving a vehicle varies from 10p for 15 minutes up to £1.30 (maximum) for 4 hours (maximum), or a vehicle displaying a valid Residents' Parking Permit, available from the London Borough of Croydon at a cost of £10 per annum, may park for a period of 8 hours (maximum).

(N.B. Existing charges for 'pay and display' parking places varies from 10p for 24 minutes up to 50p (maximum) for 2 hours (maximum) and from 10p per 50 minutes up to 60p (maximum) for 5 hours (maximum) respectively).

(g) provide that the excess charge (payable to the London Borough of Croydon) will be £20 (£10 if payment is received within seven days), the excess period will be 2 hours in respect of 'pay and display' parking places.

- (h) provide that certain vehicles may wait free of charge in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit)
