THE BRISTOL WATERWORKS COMPANY (DROUGHT) (No. 3) ORDER 1990

NOTICE OF MAKING OF GENERAL DROUGHT ORDER
NOTICE IS HEREBY GIVEN that the Secretary of State is satisfied that, by reason of an exceptional shortage of rain, a serious deficiency of supplies of water is threatened in the area of the Bristol Waterworks Company; and, in exercise of his powers under section 131 of the Water Act 1989, by Order made by Statutory Instrument, authorises the Company from 13th December 1990 until 23rd May 1991 to: abstract water from the Ellenge Stream adjacent to Cheddar Reservoir, at National Grid Reference ST.437 543, at a rate not exceeding 7 megalitres a day, and discharge such water into Cheddar Reservoir at National Grid Reference ST.437 542: provided that the flow of water in the Ellenge Stream, as measured at the point of abstraction, shall not fall below 1 megalitre per day.
