OFF STREET PARKING PLACES AMENDMENT ORDER

NOTICE IS HEREBY GIVEN that Middlesbrough Borough Council have made an Order on the 11th day of December 1990, under section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The Order comes into operation on 20th December 1990. The effect of the proposed Order will be as follows: to increase the charges for the short stay car parks to 60p for a period of two hours and 60p for each hour thereafter. To increase the charges for long stay car parks to 70p per day. Season tickets will be made available for the period of three, six and twelve months, at a charge of £35.00, £70.00 and £140.00. In addition to the proposed Order the charge of the Essential User Permits is to be increased to £77.00 per annum. This Notice replaces the previous Notice as published in the *London Gazette* on the 11th December 1990. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the power of the relevant section of the Road Traffic Regulation Act 1984 or of any requirement of that Act or any enactment made under it has not been complied with in relation to the Order you may within six weeks from the 13th December 1990, apply to the High Court for this purpose.
