ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A487) (Bryncir, Gwynedd) (40 m.p.h. Speed Limit) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 84 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the driving of motor vehicles at a speed exceeding 40 mph in the length of road specified in the Schedule to this notice.

Stopping-up of a length of highway fronting Bumpston Cross Cottage, Buckfastleigh
