##### *Mid Glamorgan County Council (Talbot Green By-Pass) (Prohibition of Pedestrians) Order 1991*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the use by pedestrians of the lengths of road specified in the Schedule to this notice.

Exemptions will be provided in the Order to permit pedestrians to use the length of road referred to for the purposes of preventing or avoiding an accident and to cross the roads between continuous lengths of public footpaths, the maintenance of essential services and emergency services, for the recovery of any object falling onto the road or as a result of the breakdown of a vehicle. The prohibition will not apply to any area designated and marked as a lay-by.

##### *Lengths of Road in the Borough of Taff Ely*

1. Route A473 Talbot Green By-pass from a point 50 metres (55 yards) east of Lanelay roundabout eastwards to a point 10 metres (11 yards) west of the roundabout at its junction with route A4119, Llantrisant Road, a distance of approximately 1,490 metres (1,630 yards).

2. Talbot Green By-pass from the eastern side of the roundabout at its junction with route A4119, Llantrisant Road eastwards and north-eastwards to the south-eastern side of the roundabout at its junctions with Rhiwsaeson Road, a distance of approximately 770 metres (843 yards).

3. Talbot Green By-pass from a point 35 metres (38 yards) north-east of the roundabout at its junction with Rhiwsaeson Road north-eastwards for a distance of 535 metres (585 yards).

##### *Mid Glamorgan County Council (Talbot Green By-pass) (24 hour Carriageway Clearway) Order 1991*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the waiting of vehicles at any time on the length of road referred to in the Schedule to this notice.

Exemptions will be provided in the Order for the purpose of building or roadworks; the maintenance of essential services; the delivery or collection of postal packets by vehicles in the service of the Post Office; local authority or water authority vehicles, in pursuance of statutory powers or duties; access to adjoining premises whilst a gate or barrier is opened or closed; a requirement of the law, to avoid an accident or for circumstances outside the control of the driver.

##### *Lengths of Roads in the Borough of Taff Ely*

(1) Talbot Green By-pass, Route A473, from a point 55 metres (60 yards) north-east of Rhiwsaeson roundabout south-westwards to a point 50 metres (55 yards) southwest of the roundabout to include the gyratory carriageway. A distance of approximately 150 metres (162 yards).

(2) Talbot Green By-pass, Route A473, from a point 55 metres (60 yards) east of the roundabout at its junction with A4119, Llantrisant Road, westwards to a point 50 metres (55 yards) west of the roundabout a distance of approximately 175 metres (191 yards).
