Gwent County Council (Llwyn Helyg, Tredegar) (Prohibition of Waiting) Order 1990

In this Schedule: The *Waundeg Housing Estate Access Road*, which forms a junction with *Llwyn Helyg*, 30 metres north-west of and opposite the junction of *Golwg-y-Mynydd* with *Llwyn Helyg* shall be known as *Road A*.

Prohibition of waiting at any time

- (1) *Llwyn Helyg*:
