*The County Council of Shropshire (London Road and Wenlock Road, Shrewsbury) (Prohibition of Commercial Vehicles of over 7.5 tonnes) Order 19*

*The County Council of West Sussex (Steyning: Footpath No. 2858 (Part)) (Temporary Closure) Order 1991*
