## HIGHWAYS ACT 1980

*The Northamptonshire County Council (A422 Deanshanger Bypass Classified Road) (Side Roads) Order 1990*

Notice is hereby given that the Northamptonshire County Council hereby give notice that they have made, and submitted to the Secretary of State for Transport for confirmation, an Order under sections 14 and 125 of the Highways Act 1980 for authorising the council:

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises,
- (e) to provide new means of access to premises,

all on or in the vicinity of the route of the classified road which the county council are proposing to construct from a point 35 metres north of Bridledean Cottage in a generally north-easterly direction to a point 130 metres south of the existing Passenham Lane and which will include a roundabout junction of the existing A422 and the realigned Passenham Lane.

2. Part of the Highway known as Fairlands Way for an area of 110 metres square from the footpath adjacent to 112 Mobbsbury way running alongside that property to the rear fence.
3. Part of the Highway forming part of the footpath leading from Beverley Road for an area of 73 metres square adjacent to 15 Beverley Road and running from the front boundary to the rear boundary of that property.

## CUMBRIA COUNTY COUNCIL

## WILDLIFE AND COUNTRYSIDE ACT, 1981

*Cumbria County Council (Bardsea Park) Limestone Pavement Order 1990*

Notice is hereby given that on 14th December 1990, Cumbria County Council acting under section 34 of the Wildlife and Countryside Act 1981 made the *Cumbria County Council (Bardsea Park) Limestone Pavement Order 1990* designating the land described in the Schedule to the Order and prohibiting the removal or disturbance of limestone on or in it.

The Order (which is set out in the Schedule to this Notice) took effect when it was made and has been submitted to the Secretary of State for the Environment. The Order will cease to have effect nine months after it was made unless the Secretary of State previously gives notice that he has considered it and does not propose to amend or revoke it, or that he has amended or revoked it, or that the Authority has revoke it.

Representations about or objections to the Order may be made to the Secretary of State for the Environment, Room 908, Tollgate House, Houlton Street, Bristol BS2 9DJ, before 19th January 1991.

Such representations or objections should be in writing and should state the title of the Order. In the case of objections, the grounds on which they are made should also be stated.

*Cumbria County Council (Bardsea Park) Limestone Pavement Order 1990*

Whereas the land described in the Schedule to this Order comprises a limestone pavement which has been notified to Cumbria County Council under section 34(1) of the Wildlife and Countryside Act 1981.

And whereas it appears to the Cumbria County Council that the character or appearance of the said land will be likely to be adversely affected by the removal of the limestone or its disturbance in any way whatever, that the Council ought to order as follows:
