the charge for parking a motor cycle will be 30p for any period up to 24 hours when charges are applicable (charge unchanged).

Full details are contained in the Order which, together with the Council's reasons for making the Order and copies of the Orders amended, may be inspected at the Town Hall, Queens Road, Hastings, during normal office hours which are Monday to Thursday, 9 a.m. to 5 p.m. and Friday, 9 a.m. to 4.30 p.m.

Any person who wishes to question the validity of the Order on the grounds that it is not within the powers of the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it, have not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

## HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (Various Roads, Worcester) Various Traffic Orders 1990

Notice is hereby given that Hereford and Worcester County Council propose to make Orders under sections 1(1) and (2), 2(1) to (3), 4(2), and 45 of the Road Traffic Regulation Act 1984 and of all other enabling powers the effect of which will be:

(1) (Mill Street, Worcester) (One-Way Traffic) Order 1990

To prohibit any vehicles other than mechanical road cleansing vehicles from proceeding in a direction other than southerly in that length of Mill Street in the City of Worcester in the County of Hereford and Worcester which extends from its junction with Severn Street for a distance of 68 metres (223 feet) in a southerly direction.

- (2) (Mill Street, Portland Street, Portland Walk and Willow Street, Worcester) (Prohibition and Restriction of Waiting) Order 1990
  - (a) to prohibit waiting at any time in the sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester specified in Schedule 1 to this notice;
  - (b) to prohibit waiting between the hours of 8.30 a.m. and 5.30 p.m. on Monday to Saturday inclusive on the sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester specified in Schedule 2 to this notice:
    - (i) For a period exceeding 3 hours; or
    - (ii) If a period of less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the sides of lengths of roads.

Exemptions in the Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and/or unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply and maintenance of any gas, electricity, water and telecommunications apparatus;
- (f) the fire brigade, ambulance or police services;
- (g) the pursuance of statutory powers or duties (if no other road can be conveniently used).

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's Orange Badge Scheme for a limited period of 2 hours, return prohibited within a further period of 1 hour.

(3) The Parking Places (Mill Street, Portland Street and Willow Street, Worcester) Order 1990

To authorise the sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester specified in Column 2 of Schedule 3 to this notice as parking places for any resident (see next paragraph) who is the owner of a passenger vehicle, a goods vehicle or a motor cycle and displays a parking permit issued by the County Council.

The charge for a parking permit if the Order is subsequently made will be £30 per annum and these will be obtainable on written application to the County Secretary and Solicitor, County Hall, Worcester. Any resident of Mill Street, Portland Street and Willow Street, Worcester will be eligible to apply for a parking permit.

Any person parking in the parts of the roads specified above shall not unreasonably prevent access to any premises adjoining the parts of roads or the use of the parts of the roads by other persons, so as to be a nuisance, and shall park in the position described in the third column of Schedule 3 to this notice.

Any vehicles, being in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills or services, are prohibited from using the said parking places except if the goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is affected or if the person is licensed by the Council to sell goods from a stationary pitch situated in the parking place.

The County Council may suspend the use of a parking place or any part thereof whenever such suspension is considered necessary

for the following:

- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
- (b) for the convenience of occupiers or premises adjacent to the parking place at times of weddings or funerals or on other special occasions;
- (c) on any occasion on which it is likely by reason of some special attraction that any street will be throughd or obstructed.

Exemptions are also contained in the Order for the purposes of (a) to (g) in Article 1 above and also owing to circumstances beyond the driver's control or to avoid an accident.

A copy of the draft Orders and map showing the length and sides of lengths of roads affected and a copy of the County Council's statement of reasons for proposing to make the Orders can be inspected (from Monday to Friday during normal office hours at the County Hall, Spetchley Road, Worcester; and Worcester City Council Offices, The Guildhall, Worcester.

Objections to the proposal, giving reasons, must be sent in writing to the undersigned by 4th May 1990.

## SCHEDULE 1

Sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester

(1) Mill Street:

- (a) eastern and northern side, from its junction with Severn Street in a southerly direction for a distance of 203 metres (666 feet) to a point 50 metres (164 feet) north-west of its eastern junction with Portland Street.
- (b) western side:
  - (i) from its junction with Severn Street for a distance of 47 metres (154 feet) in a southerly direction.
  - (ii) from a point 71 metres (233 feet) south of its junction with Severn Street for a distance of 18 metres (59 feet) in a southerly direction to a point 27 metres (89 feet) north-west of its western junction with Portland Street.
- (c) southern side:
- (i) from its western junction with Portland Street for a distance of 42 metres (138 feet) in an easterly direction to its junction with Willow Street.
- (ii) from its junction with Willow Street for a distance of 96 metres (315 feet) in an easterly and southerly direction to a point 14 metres (46 feet) north-west of the centre line of its eastern junction with Portland Street.
- (2) Portland Street:
  - (a) South-western side, from a point 49 metres (161 feet) southeast of its western junction with Mill Street for a distance of 20 metres (66 feet) in a south-westerly direction.
  - (b) north-eastern side, from its western junction with Mill Street for a distance of 116 metres (381 feet) in a south-easterly direction to its junction with Portland Walk.
  - (c) north-western side:
    - (i) from its junction with Willow Street for a distance of 25 metres (82 feet) in a north-easterly direction.
  - (ii) from its junction with Willow Street for a distance of 50 metres (164 feet) in a south-westerly direction to its junction with the western arm of Portland Street.
  - (d) south-eastern side, from a point 37 metres (121 feet) northeast of its junction with Portland Walk for a distance of 10 metres (33 feet) in a north-easterly direction.
- (3) Willow Street:
- (a) north-eastern side, from its junction with Mill Street for a distance of 57 metres (187 feet) in a south-easterly direction.
