In a general north-westerly direction from the point previously mentioned north of Banbury in the preceding paragraph passing to the east of Shotteswell, the route diverging for a distance of about 1,200 metres (1,308 yards) and merging as indicated on the deposited plan, the motorway comprising both of the routes, passing to the east of Warmington, to the west of Avon Dassett and Burton Dassett under Kineton Railway, and to the east of Gaydon as far as a point in the County of Warwickshire about 1,200 metres (1,308 yards) north-west of the B4451 Classified Road north of Gaydon (the motorway along this route being on Plan C and C2 in the deposited plan).
4. In a general north-westerly direction from the point previously mentioned north of Gaydon in the preceding paragraph passing to the north-east of Lighthorne, south-west of Bishop's Tachbrook, and south of Royal Leamington Spa and Warwick, the route diverging for a distance of about 1,500 metres (1,635 yards) and merging as indicated on the deposited plan, the motorway comprising both of the routes, as far as a point (marked "2" on Plan D in the deposited plan) about 451 metres (493 yards) north-west of the centre point of the junction of the A41 Trunk Road, the A46 Trunk Road and the A429 Principal Road south of Warwick (the motorway along this route being on Plan D in the deposited plan).
5. A route starting at a point (marked '1' on the deposited plan) about 380 metres (416 yards) north of the junction between the A421 and Wendlebury Road in the Parish of Wendlebury, and proceeding in a generally northerly direction to a point in the Parish of Chesterton (marked "2" on the deposited plan) 1.6 kilometres (1 mile) north of that junction.
6. A route starting in the Parish of Chesterton at a point (marked '1' on the deposited plan) 1.6 kilometres (1 mile) north of the junction of the A421 and Wendlebury Road, and proceeding in a generally northerly direction to a point in the Parish of Ardley (marked '2' on the deposited plan) 450 metres (490 yards) north of the junction between the A43 Trunk Road and the Stoke Lyne Road near Ardley in the County of Oxfordshire.
7. A route starting at a point on the London-Oxford-Fishguard Trunk Road (A40) about 245 metres east of Waterstock Lane in the Parish of Great Milton in the County of Oxfordshire, and proceeding in a generally north-westwards direction west of Waterperry and then in a generally north-eastwards direction west of Worminghall in the County of Buckinghamshire, and then in generally north-westwards direction south-west of Oakley and Boarstal, north-east of Fencott, Murcott and Charlton-on-Otmoor and south-west of Merton and Wendlebury ending at a point about 380 metres north of the junction between the A421 Trunk Road and Wendlebury Road in the Parish of Weston-on-the-Green in the said County of Oxfordshire.
