The M5 Birmingham-Exeter Motorway (Strensham Re-located Northbound Service Area) Connecting Roads Scheme 1991

The Secretary of State for Transport hereby gives notice that he has made a scheme under sections 16, 17 and 19 of the Highways Act 1980, the effect of which is:

The A30 Trunk Road Okehampton to Launceston Improvement

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

- (1) The A30 Trunk Road (Okehampton to Launceston Improvement and Slip Roads) Order 1991 (SI 1991 No. 84) which is an Order under sections 10 and 41 of the Highways Act 1980 providing that the roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:
 - (a) a route (the main route) about 19-50 kilometres in length between Okehampton and Launceston in the County of Devon and
 - (b) seven routes (the slip roads) one to connect the existing A30 Trunk Road with the A386, two to connect the main route with a proposed realignment of the A386, one to connect the main route with the trunk road at Sourton Down, one to connect the main route with the C439, one to connect the main route with a proposed realignment of the C613 south of Rexon Cross and one to connect the main route with the existing A30 trunk road at Liftondown.
- (2) The A30 Trunk Road (Okehampton to Launceston Improvement) (De-trunking) Order 1991 (SI 1991 No. 85) which is an Order under sections 10 and 12 of the Highways Act 1980 providing that two lengths of the A30 Trunk Road to be superseded by the new trunk road mentioned above shall cease to be trunk road, as from the date on which the Secretary of State notifies the County Council of Devon (who will become the highway authority responsible for those lengths) that the said new trunk roads are open for through traffic.
- (3) The A30 Trunk Road (Okehampton to Launceston Improvement and Slip Roads Side Roads) (No. 2) Order 1991 which is an Order under section 14 of the Highways Act 1980 authorising him to improve, raise, lower or otherwise alter nine lengths of the classified road C463 between Cross Roads and Wrixhill in the vicinity of the route of the above-mentioned new trunk road.
