#### NORTH HERTFORDSHIRE DISTRICT COUNCIL

##### *North Hertfordshire District Council (Market Place, Hitchin) (Street Parking) Order 1991*

Notice is hereby given that the North Hertfordshire District Council acting as agents for the Hertfordshire County Council propose to make the above Order under the provisions of sections 45 and 46 of the Road Traffic Regulation Act 1984, to amend the existing Orders, the effect of which will be:

(1) To introduce increased car park charges between 8 a.m. and 6 p.m. on every day except Sundays and Bank Holidays, the initial charges for which are as follows:

- 30 pence for up to 1 hour
- 40 pence for more than 1 hour and up to 2 hours
- 50 pence for more than 2 hours and up to 3 hours
- £1.20 pence for more than 3 hours and up to 4 hours
- £1.70 pence for more than 4 hours and up to 6 hours
- £2.70 for more than 6 hours

Following payment of the initial charge vehicles parked for a longer period than that for which they are entitled shall be subject to an excess charge of £20 but this sum will be reduced to £7 if paid within seven days of being demanded.

(2) To introduce parking charges in the following cases:

- (a) Failure to display a valid parking ticket on a vehicle;
- (b) Not parking within the marked bays;
- (c) Parking a vehicle in a Disabled Persons bay when not displaying a valid Orange Disabled Persons badge.

The parking charges in the situations referred to in item (2) paragraphs (a) to (d) above, will be £20 but this sum will be reduced to £7 if paid within seven days of being demanded.

The parking place is available for use by all vehicles other than hackney carriages and commercial vehicles constructed or adapted for the purpose of carrying goods and being of unladen weights exceeding 30 cwt.

A copy of the Order and other relevant documents will be available for inspection at my office and at the District Office, Brand Street, Hitchin, between 9 a.m. and 4.30 p.m. Monday to Friday.
