Borough of Southend-on-Sea (Western Road and Tattersall Gardens) Prohibition of Waiting Order 1990

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 12th April 1991, pursuant to arrangements under section 101 of the Local Government Act 1972 with the Essex County Council in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1), to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit waiting as follows:

SCHEDULE 1

Hours of Prohibition: 24 hours daily

Western Road, both sides, from a point 12 metres west of the west kerb-line of Tattersall Gardens to a point 15 metres east of the east kerb-line of Tattersall Gardens.

Tattersall Gardens, both sides, from the north kerb-line of of Marine Parade northwards for a distance of 15 metres.

Tattersall Gardens, west side, from a point 18 metres south of the south kerb-line of Western Road to a point 18 metres north of the north kerb-line of Western Road.

Tattersall Gardens, east side, from a point 18 metres south of the south kerb-line of Western Road to a point 18 metres north of the north kerb-line of Western Road.

Marine Parade, north side, from a point 20 metres east of the east kerb-line of Tattersall Gardens to its western extremity.
