The Stopping-up of Highway (Penhow, Newport, Gwent) Order 199
The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highways described in the Schedule to this notice to enable development of a

new hotel and tourist complex, for which planning permission has been granted, to be carried out.
