PROPOSED STOPPING UP OF HIGHWAYS AT RINGWAY, MANCHESTER

The Secretary of State for Transport hereby gives notice that on the application of Manchester City Council on behalf of Manchester Airport Plc he proposes to make an Order under S247 of the above Act to authorise the stopping up of Hallman Lane, a length of Woodhouse Lane, an unnamed passage

adjacent to Hallman Lane and Footpaths Nos 251 and 17 adjacent to Hallman Lane and Footpaths Nos 251 and 17 (Ringway) together with an unnumbered temporary footpath at Ringway, Manchester. The Order, if made, would enable development of extension of Airport Car Parks and construction of Rail Link to Manchester Airport to be carried out in accordance with planning permission granted to Manchester Airport Plc and British Railways Board.
