Notice of application for consent for the purposes of section 108

Notice is hereby given in accordance with Schedule 12 of the above Act that an application has been made to the National Rivers Authority by Severn Trent Water Ltd. for consent to discharge up to 527 cubic metres per day of treated sewage effluent to the Sarnwen Brook at National Grid Reference SJ 2748 1812 from Four Crosses Water Reclamation Works, Four Crosses Village, Powys. This is an application to replace an existing consent which currently authorises the discharge of 44 cubic metres per day of treated sewage effluent under dry weather conditions compared to the proposed new dry weather flow of 97 cubic metres per day to take into account future development in the area to 1995.
