#### TENDER FOR STERLING TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 6th September 1991 at 1 p.m. for sterling Treasury Bills to be issued under the Treasury Bills Act 1877 and the National Loans Act 1968, to the amount of £300,000,000 for Bills due 91 days after date and £100,000,000 for Bills due 182 days after date.

The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000, £500,000, £1,000,000, £5,000,000 or £10,000,000. They will be dated at the option of the Tenderer on any business day from Monday, 9th September 1991 to Friday, 13th September 1991, inclusive.

The Bills will be issued and paid at the Bank of England.

Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent (being a multiple of half of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates and different tenors.

Notification will be sent on the day of the Tender to the persons whose Tenders are accepted in whole or in part.

If delivery of Treasury Bills into the Central Moneymarkets Office has been requested, payments will be effected through that system; otherwise payment in full of the amount due in respect of an accepted Tender must be made to the Bank of England, not later than 1.30 p.m. on the day on which the relevant Bills are to be dated and on which they are to be collected from the Securities Office, by one of the following means:

#### TOWN AND COUNTRY PLANNING ACT 1990

*Proposed Stopping-up of Highways at Huyton, Merseyside*

The Secretary of State for Transport hereby gives notice that on the application of Knowsley Metropolitan Borough Council he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of a length of Bruton Road and various footpaths at Hillside, Huyton, to enable residential development consisting of rationalisation of vehicular and pedestrian layout, extension to garden areas, erection of gates, walls and fences and landscaping to be carried out in accordance with planning permission granted by Knowsley Metropolitan Borough Council under Part III of the said Act.

The proposed Order will require the improvement of existing highways and the provisions of footpaths maintainable at the public expense, for which the highway authority is to be the Knowsley Metropolitan Borough Council.
