The Bexley (Waiting and Loading Restriction) (Amendment No.) Order 19

The Bexley (Free Parking Places) (No.) Order 19

Notice is hereby given that the Council of the London Borough of Bexley propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.

The general effect of the above-mentioned Order will be to introduce a system of controlled parking in the Albany Park and Bexley Station Areas, in the London Borough of Bexley in the streets and parts of streets listed in Schedules 1 and 2 respectively, to this notice (hereafter referred to as the "controlled areas").

The Free Parking Places Order would:

- (a) designate parking places on the highway in the London Borough of Bexley specified in Schedules 3 and 4 to this notice for vehicles authorised by the Order to be left free of any charge;
- (b) provide that the parking places will operate between 10 a.m. and 11 a.m. in Bexley Station Area and 11 a.m. and 12 noon in Albany Park Station Area on Mondays to Fridays inclusive (except Christmas Day, Good Friday and Bank Holidays);
- (c) specify that passengers vehicles (12 seats or less), goods vehicles not more than 2.28 metres in height, motor cycles or invalid carriages may be left therein;
- (d) provide that certain vehicles are exempt from the limitations e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes).

The Bexley Waiting and Loading Restriction Order further amends the Bexley (Waiting and Loading Restriction) Order 1991, so that:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle), except in designated parking places, will be prohibited between 10 a.m. and 11 a.m. on Mondays to Fridays inclusive in the streets and parts of streets specified in Schedule 5 to this notice;
- (b) Waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) except in designated parking places will be prohibited between 11 a.m. and 12 noon on Mondays to Fridays inclusive in the streets or parts of streets specified in Schedule 6 to this notice.
- (c) Waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 12 noon on Mondays to Fridays in the streets or parts of streets specified in Schedule 6 to this notice.
- (d) Waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) except in designated parking places will be prohibited between 8 a.m. and 6.30 p.m. Monday to Saturday inclusive in parts of Bourne Road, Parkhill Road, Parkhurst Road, Hurst Road, Southwold Road, and Elmington Close.
- (e) The restrictions on waiting by vehicles which now apply between 8 p.m. and 6.30 p.m. on Mondays to Fridays in parts of Steynton Avenue, will be amended so that the restrictions apply between 8 p.m. and 6.30 p.m. Mondays to Saturdays inclusive.
- (f) Waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 6.30 p.m. on Mondays to Saturdays in parts of Bourne Road, Elmington Close, Hurst Road, Parkhill Road, Parkhurst Road, Southwold Road and Steynton Avenue.
- (g) The restrictions on waiting by vehicles, which now apply between 8 a.m. and 6.30 p.m. on Mondays to Saturdays in parts of Thanet Road, Manor Way and Salisbury Road, Bexley will be amended so that the restrictions apply between 10 a.m. and 11 a.m. on Mondays to Fridays inclusive.
- (h) The restrictions on waiting by vehicles, which now apply between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays in Steynton Avenue will be amended so that the restrictions apply between 11 a.m. and 12 noon on Mondays to Fridays inclusive.

- (i) The use of any vehicle or of any animals or the wearing of fancy dress or costume wholly or mainly for the purpose of advertising, in the streets or parts of streets referred to in Schedules 1 and 2 to this notice will be prohibited;

(N.B. the restrictions on waiting by vehicles which now apply in certain parts of Bexley High Street, Bourne Road, Parkhill Road, Thanet Road and Hurst Road between 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive will remain unchanged;)

5. The prohibition referred to in paragraphs 4 above would not apply in respect of anything done with the permission of or at the discretion of a police constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol from roadside petrol stations, etc. The usual exemption relating to vehicles displaying a disabled person's "orange badge" will apply.

Copies of the proposed Orders, The Bexley (Waiting and Loading Restriction) Order 1991 (and of the Orders which amended that Order), a map which indicates each length of street to which the Orders relate and the Councils' statement of reasons for proposing to make the Orders can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of 21 days from the date on which this notice is published at:

8. Persons desiring to object to the Bexley Orders should send a statement in writing of their objections and the grounds thereof to The Chief Engineer, London Borough of Bexley, Sidcup Place, Sidcup, Kent DA14 6BT, within the afore-mentioned period of 21 days.

9. Persons objecting to the proposed Orders would be aware that in view of the Local Government (Access to Information) Act 1985, the relevant Council would be legally obliged to make any comments received to this notice, open to public inspection.
