The designation of this extension to the conservation area takes effect from the date of the Council's decision, i.e. 29th May 1991.

The consequences of designating this area as an extension to the conservation area are as follows:

- 1) certain buildings may only be demolished with the consent of the Council;
- (2) it becomes an offence to cut down, top, lop, uproot, willfully damage, or willfully destroy any tree in the area;
- (3) the Council are under a duty to formulate and publish
- proposals for the preservation and enhancement of the area;
  (4) the Council must pay special attention to the desirability of preserving or enhancing the character or appearance of the area when exercising its powers under the Planning Acts;
  (5) planning applications which affect the character or appearance
- of the area must be publicised;
- (6) permitted development rights under the General Development Order 1988 are more restricted;
- (7) specific duties are imposed on telecommunications operators by their licences;
- (8) the right to display some types of illuminated advertisements in excluded;
- (9) grants and loans may become payable by the Council.

The boundary then skirts the southern edge of the railway viaduct to the east side of Minories and includes the east side of Minories to the boundary with Tower Hamlets.

19. Leadenhall Market

The effect of the designation of the Conservation Areas may be summarised as follows:

- (a) Where an application for planning permission for any development of land in or adjacent to a conservation area is made to the local planning authority and the development would, in the opinion of the local planning authority, affect the character or appearance of the conservation area, the application will be subject to the special procedure in section 67 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as applied by section 73 of that Act).
- (b) Anyone wishing to demolish a building or a part of a building situate within the conservation area must first apply for conservation area consent to the local planning authority. This is not taken to be included in a planning permission for redevelopment of the site unless, in granting the planning permission, the authority states that it includes consent to demolish the building, Some buildings may be exempt from this requirement.
- (c) Anyone wishing to cut down, top, lop or uproot a tree situate within a conservation area must either:
  - (i) seek the consent of the local planning authority in whose area the tree is or was situate; or
  - (ii) give 6 weeks prior notice of his intention to the local planning authority in whose area the tree is or was situate.

The precise boundaries of the areas described above are shown on a map entitled City of London (Conservation Areas Map) 1991, which may be inspected free of charge at the office of the City Planning Officer at Guildhall, London E.C.2, during normal office hours.
