## ROAD TRAFFIC ACTS

## BARNSELY METROPOLITAN BOROUGH COUNCIL

*The Metropolitan Borough of Barnsley (Barnsley) (Bus Priority) Order 1987 (Amendment No. 2) Order 1991*

Notice is hereby given that on 2nd September 1991, the Barnsley Metropolitan Borough Council made the above named Order under the provision of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation from midnight on 14th September 1991, will be to prohibit any public service vehicle from proceeding in that whole length of Midland Street at Barnsley which exceeds from Eldon Street to Kendray Street, and to remove the five public service vehicle stands situate thereon. Local bus services previously operating from Midland Street shall thereafter be transferred to the East Bus Station.

A copy of the Order and a map showing the restricted road may be examined during normal office hours at the offices of (i) the Barnsley Metropolitan Borough Council, Town Hall, Barnsley, and (ii) Central Library, Shambles Street, Barnsley.
