### NORTH DORSET DISTRICT COUNCIL

#### PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990, SECTION 69 AND 70

Notice is hereby given for the purpose of section 69 and 70 of the Planning (Listed Buildings and Conservation Areas) Act 1990 ("the Act") of the cancellation of the designation by the North Dorset District Council of the Bath Road area and the Livestock Market Area near and around the centre of Sturminster Newton, Dorset as a conservation area as defined by the said Act, the said North Dorset District Council being the local planning authority for the area in which the said former conservation area is situate. A plan showing the precise boundaries of the former conservation area may be inspected at the offices of the said North Dorset District Council at Nordon, Salisbury Road, Blandford Forum, Dorset.

The consequences of the said cancellation are that:

- (1) demolition of buildings can now be carried out without conservation area consent.
- (2) any person intending to cut down, lop or do other similar work on trees in the area need no longer comply with section 211 of the Town and Country Planning Act 1990 by getting the Councils prior written consent or giving prior notice to the Council, but all the provisions of any tree Preservation Order must still be fully complied with.
- (3) the authority will not be under a duty under section 71(1) of the Act to formulate and publish proposals for the preservation and enhancement of the area.
- (4) planning applications for development will no longer need publicity under section 67 of the Act.
