Notice is hereby given that the above-named Order, made on 3rd September 1991, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed by the Tameside Metropolitan Borough Council ("the Council") as an unopposed Order.

The effect of the Order, if confirmed without modifications, will be to create a footpath from the south-westerly end of Roe Cross Green to the northern end of Footpath 40, Mottram-in-Longdendale and shown running from point A to point B on the deposited plan.

A copy of the Order and the map contained in it has been deposited and may be inspected, free of charge, at Tameside Information Offices, Council Offices, Wellington Road, Ashton-under-Lyne and the Information Office, Courthouse, Mottram, Tameside between 8.30 a.m. and 5 p.m. Monday to Wednesday, 8.30 a.m. and 4.30 p.m. on Thursday and 8.30 a.m. and 4 p.m. on Friday, (copies of the map and Order may be purchased).

Compensation for depreciation or damage in consequence of the coming into operation of the Order is payable in accordance with section 28 of the Highways Act 1980 to which reference should be made.

Any representation or objection with respect to the Order may be sent in writing to the Borough Solicitor, Tameside Metropolitan Borough Council, Council Offices, Wellington Road, Ashton-under-Lyne, Tameside OL6 6DL, quoting ref. BL/162/51/NJH not later than 10th October 1991 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Tameside Metropolitan Borough Council may instead of submitting the Order to the Secretary of State for the Environment confirm the Order itself. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be submitted with the Order.
