The County of Cambridgeshire (Ermine Street, Alconbury, Great and Little Stukeley) (Prohibition of Heavy Commercial Vehicles) Order 1991.

Notice is hereby given that on 30th August 1991, the Cambridgeshire County Council made an Order under the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers the effect of which is to prohibit heavy commercial vehicles exceeding 7.5 tonnes from using Ermine Street through Great and Little Stukeley and Alconbury between Spittals Way and Rusts Lane.

CITY OF LONDON

The City of London (Prescribed Route) (No. 2) Traffic Order 1991

Notice is hereby given that the Common Council of the City of London on 6th September 1991, made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road -Traffic Regulation Act 1984, as amended by the Local Government Act 1985, so as to continue in force indefinitely the provisions of the City of London (Prescribed Route) (No. 1) Experimental Traffic Order 1990.

The general effect of the Order will be to impose one-way working for vehicular traffic from north to south in Ironmonger Lane, between Gresham Street and a point 26 metres north of the northern kerb-line of Cheapside.

Exemption has been provided in the Order:

- (a) in respect of anything done with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the City Police.

Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
