*The Borough of Elmbridge (Waiting and Loading Restriction) (Revocation) (No. 2) Order 1991*

#### GATESHEAD METROPOLITAN BOROUGH COUNCIL

*The Borough Council of Gateshead (South Shore Road, Gateshead) (Prohibition of Waiting) Order 1991*

Notice is hereby given that on 10th September 1991 the Borough Council of Gateshead made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of the Order, which comes into operation of 15th September 1991, will be to introduce a "No Waiting at Anytime" restriction on that length of South Shore Road, Gateshead, which extends from a point 22.8 metres west of the entrance to HMS *Calliope* in a westerly direction for 91 metres. Normal exemptions would apply, including those for disabled persons vehicles.

#### GATESHEAD METROPOLITAN BOROUGH COUNCIL

*The Borough Council of Gateshead (Front Street Whickham — Disabled Parking Place and Limited Waiting) Order 1991*

Notice is hereby given that on 10th September 1991, the Borough Council of Gateshead made an Order under sections 1, 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order, which comes into operation on 15th September 1991, will be to:

- (a) revoke the existing No Waiting at Anytime restriction on the north side of front Street Whickham which extends from a point 20 metres west of its junction with Rectory Lane in a westerly direction for 72 metres;
- (b) introduce two disabled parking bays on the north side of Front Street from a point 20 metres west of its junction with Rectory Lane westwards for 12 metres; and
- (c) introduce limited waiting 8 a.m. to 6 p.m. (Monday to Saturday) 1 hour in any 2 hours on the north side of Front Street from a point 32 metres west of its junction with Rectory Lane westwards for 60 metres.

Normal exemptions would apply to the limited waiting restriction.

#### MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Cemetery Road, Bridgend) (Variation) and (Prohibition of Waiting) Order 1991*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which will be:

- (i) To vary the provisions of the "Mid Glamorgan County Council (Cemetery Road) Prohibition of Waiting Order 1976" by the deletion from that Order of the reference to the north-eastern side of Cemetery Road, Bridgend, from its junction with Coity Road north-westwards for a distance of 15 metres (16 yards).
- (ii) To prohibit the waiting of vehicles at any time on the sides of lengths of road specified in the Schedule to this notice.

Exemptions will be provided in the Order to enable Medical Practitioners and Veterinary Surgeons to visit while "on call" and for the purposes of boarding, alighting, loading, unloading, building and roadworks, the maintenance, improvement, reconstruction, inspection or survey of the sides of lengths of road, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait up to 2 hours with return prohibited within 1 hour.
