LAND COMPENSATION ACT 1973 (AS AMENDED)

The Secretary of State for Transport hereby gives notice, that the length of Highway detailed in the Schedule below was first open to public Traffic on 12th February 1989.

Under Part I of the Land Compensation Act 1973 (as amended) there is a right to compensation in respect of any depreciation of more than £50 in the value of certain interests on land caused by the use of new or altered highways and resulting from specified pyhysical factors (noise, vibration, smell, fumes, smoke and artificial lighting and the discharge on to the land in respect of which the claim is made of any solid or liquid substance). Compensation is assessed by reference to prices current at a date twelve months after the highway is first open to public traffic or, in the case of an altered highway, first open to public traffic after completion of the alterations.

Interests qualifying for compensation are specified in section 2 of the above-mentioned Act and there are special provisions relating to claims by mortgagees and persons entitled under trusts or settlements. However, no compensation can be paid under Part I where part of a property has been acquired for the purpose of constructing the highway.

Any person entitled to a qualifying interest who considers they have a claim under the said provisions may obtain further information and claim forms from the Director, (Network Management Division), Department of Transport, West Midlands Regional Office, No. 5 Broadway, Broad Street, Birmingham B15 1BL.

Claims should be made within six years from 12th February 1990. If an interest is disposed of or (insofar as the interest is in land which is not a dwelling) a tenancy is granted, the claim must be made before such disposal or grant of tenancy. However if any person disposed of an interest between 12th February 1989, and the date of this notice, a claim may be made now.

Notification by a Public Gas Supplier of Intention to Execute Works for the Construction of High Pressure Pipelines

In accordance with section 20(1) of the Gas Act 1986 (C44), the Director General of Gas Supply has received notice from British Gas plc, a public gas supplier within the meaning of that Act, of its intention to execute works for the construction of a high pressure pipeline for the conveyance of Natural Gas or Substitute Natural Gas, as follows:

Sections 20(4) and (5) of the Gas Act 1986 provide that the Director General of Gas Supply may give directions as to the capacity of a proposed pipeline and as to the cost of its construction, if satisfied in the light of representations;

- (a) that a demand exists or is likely to arise for the conveyance of gas of, or of a kind similar to, the kind specified in the notice relating to a proposed pipline and
- (b) that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so specified.

Any representations as to such matters should be made in writing and delivered to the Director General of Gas Supply, Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT, in such manner that:

- (a) an indication in respect of the gas for the conveyance of which a demand may exist or be likely to arise, of
 - (i) its origin.
 - (ii) its quantity; and
 - (iii) the rate at which it may be conveyed.
 - is delivered within 28 days of publication of this notice; and
- (b) any other and further representations are delivered within 90 days of publication. (57 SI)
