

## NORTHAMPTONSHIRE COUNTY COUNCIL

*The Northamptonshire County Council (Old A508 Northampton to Old Stratford Road) (Prohibition of Right-turn) Order 1991*

Notice is hereby given that the Northamptonshire County Council have made the above-named Order under sections 1(1) and (2) and 2(1) to (3) and Schedule 9 to the Road Traffic Regulation Act 1984. The general effect of the Order is to prohibit the "right-turn" move of all vehicles 430 metres north of the new River Tove road bridge on the Old A508 Northampton to Old Stratford Road.

A copy of the Order, together with a plan showing the length and position of the road affected may be inspected at the offices of the undersigned between the hours of 9 a.m. and 12 noon and 2 p.m. and 4 p.m., on Mondays to Fridays inclusive; or at Yardley Gobion Post Office, 10 High Street, Yardley Gobion, during normal opening hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulations Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it has not been complied with in relation to that Order, you may within 6 weeks from 13th September 1991, apply to the High Court for this purpose.

The Order will become effective from 14th September 1991.

*The Northamptonshire County Council (Old A508 Northampton to Old Stratford Road) (Restriction of waiting) Order 1991*

*Lengths of roads at Chadderton in the Borough of Oldham*

*Cobden Street*, extending from its junction with Stockfield Road for a distance of 40 metres in a north-easterly direction.

*Stockfield Road*, extending from a point 20 metres west of its junction with Cobden Street to a point 20 metres east of that junction.

*Lengths of roads at Shaw in the Borough of Oldham*

*Cowie Street*, south side, extending from its junction with Smallbrook Road for a distance of 40 metres in a westerly direction.

*Cowie Street*, north side, extending from its junction with Smallbrook Road for a distance of 15 metres in a westerly direction.

*Smallbrook Road*, west side, extending from a point 38 metres south of its junction with Cowie Street to a point 15 metres north of that junction.

*Smallbrook Road*, east side, extending from a point 15 metres south of its junction with Wrens Nest Avenue to a point 40 metres north of that junction.
