The Rotherham Borough Council (Various Roads at Ravenfield, Dolton, Thrybergh, Aston-Cum-Aughton, Whiston, Ülley, Morthen, Brampton-en-le-Morthen, Greasbrough, Kimberworth, Brompton Bierlow and North Anston) (Prohibition of Commercial Vehicles over 7.5 Tonnes Gross Weight) Order 1991.

Notice is hereby given that on 12th September 1991 the Rotherham Borough Council made the above-mentioned Order, which comes into force on 24th September 1991. The Order was made under sections 1(1) and (2), 2(4) and 3(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and all other enabling powers, and the effect of the Order will be to replace the prohibition of commercial vehicles of over 3 tons unladen weight (which has exprired by operation of law) contained in the six Orders mentioned in Schedule 1 to this notice by a prohibition of heavy commercial vehicles (as defined in section 138 of the Road Traffic Regulation Act 1984) of over 7.5 tonnes gross weight. The exemptions mentioned in the six Orders will continue.

The roads and lengths of road which will be subject to the prohibition are set out in Schedule 2 to this notice.

Copies of the new Order, the six Orders mentioned in Schedule 1 to this notice, and maps relating to the new Order, may be inspected during normal office hours at the offices of the Rotherham Borough Council at the Civic Building, Walker Place, Rotherham.

Any person wishing to question the validity of the new Order on the ground that it is not within the powers of the Road Traffic Regulation Act 1984 or that a requirement of that Act or of any relevant regulations made thereunder has not been complied with may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
