

- (c) *Priory Close*, both sides including turning head but excluding parking bays on south side adjoining the Post Office.
- (d) *Reedham Road*, both sides from the junction with The Street, to the junction with the B1140 south of Damgate Lane.
- (e) *Damgate Lane*, both sides from the junction with Reedham Road for approximately 44 metres.
- (f) *Peter Avenue*, both sides excluding east-west section.
- (g) *Norwich Road*, both sides from the junction with The Street to the junction with the B1140 link road.
- (h) *B1140 Link Road*, both sides for approximately 50 metres from Norwich Road and the slip road from the A47 Bypass.
