Road in a southerly and thence easterly direction for the remainder of its length.

An exemption is included in the Order, which allows any vehicle being used under and in accordance with an authorisation given by the Council, to enter on or proceed in that length of road provided the authorisation is displayed in a conspicuous position on the vehicle.

Exemptions are also provided in the Order for any vehicle being used in connection with the removal of obstruction to traffic, the maintenance, improvement or reconstruction of the road or services therein; in the service of a local authority or water authority in pursuance of statutory powers or duties and any vehicle being used for police, fire brigade or ambulance purposes in an emergency.

Objections and representations to this experimental Order continuing indefinitely, together with the grounds on which they are made, should be sent in writing to the undermentioned address (quoting ref. No. LET/EP-4-001) by 30th March 1992. The County Council of Avon will consider in due course whether the provisions contained in the experimental Order should be continued indefinitely. At that time any objections and comments received will be given consideration. Please note that all representations received may be considered in public by the County Council and that the substance of any representation, together with the name and address of the person making it could become available for public inspection.

The Order will come into operation on 30th September 1991, and a copy thereof together with a plan and a statement of the Councils reasons for making the Order may be inspected at the undermentioned offices (callers should report to reception and ask for the Statutory Orders Section) during normal office hours and at Staple Hill Public Library, The Square, Broad Street, Staple Hill, during normal opening hours.

Any person who desires to question the validity of, or of any provision contained in the Order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.

  - (2) Timberham Way Eastern junction in a northerly direction—anti-clockwise.
  - (3) Timberham Link from Timberham Farm Road in a southerly direction.
- (E) Impose turn left only at the junction of Cargo Road and Stokers Close and Cargo Forecourt Road.
