City of London Revision of Traffic Movements in Liverpool Street and Old Broad Street.

Notice is hereby given that the Common Council of the City of London propose to make the City of London (Prescribed Routes) (No.) Traffic Order 1991, under sections 6 and 124 of the Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Order would be to:

- (a) restore two-way working for vehicles in Old Broad Street, between Liverpoool Street, and London Wall/Wormwood Street;
